- 2. **International Competitive Bidding (ICB)** will be conducted in accordance with the Public Finance Regulation of Maldives, **Single Stage Single Envelope** bidding procedure. Qualifications requirements are stated in the Bidding Document.
- 3. Interested bidders shall register with the Ministry of Finance, between 30<sup>th</sup> June 2019 to 4<sup>th</sup> August 2019 between 0830hrs and 1200hrs on all working days, by: (a) payment of a non-refundable Registration fee of MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred) or USD 100.00, by cash/cheque at the Ministry of Finance between 0830hrs and 1200hrs on all working days, or by electronic transfer to a designated bank account, information of which can be requested through email to aminath.naaheen@finance.gov.mv; and, (b) submitting in person or emailing the following information:

  - Name, e-mail ID and telephone numbers of the Contact Person(s)
  - Copy of the Payment/Transaction Receipt.

The Employer shall not be liable for any information not received by the Bidder. It is the Bidder's responsibility to verify the website for the latest information related to this Bid.
- 5. The Bidder shall furnish a Bid Security for each of the project for the amount specified in clause 1 of this Invitation. The Bid Security shall be valid for 28 days beyond the validity of the Bid.

- 6. Commencing on 30<sup>th</sup> March 2019, only a listed member of the National Contractors Registry will be eligible to participate in this tender. Only Contractors who has been qualified for the above mentioned grades in clause 1 of this invitation will be eligible to participate for this tender.
