Bids shall be valid for a period of 120 days from the date of bid opening and shall be delivered to the Ministry of Finance at the address specified in Clause 9 of this Invitation for Bids, on or before <u>1100 hrs</u> <u>Maldivian Time on 4th April 2019</u>, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening.
