- 2. **International Competitive Bidding (ICB)** will be conducted in accordance with the Public Finance Regulation of Maldives. Qualifications requirements are stated in the Bidding Document.
- 3. Interested bidders shall register with the Ministry of Finance, between **07**th **April 2019 to 07**th **May 2019 between 0830hrs and 1200hrs (During Ramazan: 1000hrs to 1200hrs)** on all working days, by: (a) payment of a non-refundable Registration fee of **MVR 1,500.00** (Maldivian Rufiyaa One Thousand Five Hundred) or USD 100.00, by cash/cheque at the Ministry of Finance between 0830hrs and 1200hrs on all working days, or by electronic transfer to a designated bank account, information of which can be requested through email to <a href="mailto:ibrahim.aflah@finance.gov.mv">ibrahim.aflah@finance.gov.mv</a>; and, (b) submitting in person or e-mailing the following information:

- 5. The Bidder shall furnish a Bid Security for each of the project for the amount specified in clause 1 of this Invitation. The Bid Security shall be valid for 28 days beyond the validity of the Bid.
- 6. Commencing on 30<sup>th</sup> March 2019, only a listed member of the National Contractors Registry will be eligible to participate in this tender. Only Contractors who has been qualified for the above mentioned grades in clause 1 of this invitation will be eligible to participate for this tender.

- 8. Late bids will be rejected.
