1. The Government of the Republic of Maldives has received financing from Opec Fund for International Development (OFID) and intends to apply portion of the financing for eligible payments under the contract for the following projects.
2. The Ministry of Finance (MoF) on behalf of the Ministry of National Planning and Infrastructure (MNPI), now invites sealed Bids from eligible and qualified bidders for the following works.

The Employer shall not be liable for any information not received by the Bidder. It is the Bidder's responsibility to verify the website for the latest information related to this Bid.
 6. The Bidder shall furnish a Bid Security for each of the project for the amount specified in clause 1 of this Invitation. The Bid Security shall be valid for 28 days beyond the validity of the Bid.
 7. Commencing on 30th March 2019, only a listed member of the National Contractors Registry will be eligible to participate in this tender. Only Contractors who has been qualified for the above mentioned grades will be eligible to participate for this tender.

 9. Bids shall be valid for a period of **120 days** from the date of Bid of Opening and shall be delivered to the Ministry of Finance at the address specified in the Clause 8 of this Invitation for Bids, on or before **11:00hrs**, Maldivian time on **23rd January 2020**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
