5. The Bidder shall furnish a bid security of **MVR 100,000.00 (Hundred Thousand Maldivian Rufiyaa- MVR or equivalent in US dollars)** for the project. The Bid security shall be valid for 148 days from the date of bid opening

Bids shall be valid for a period of 120 days from the date of bid opening and shall be delivered to the Ministry of Finance at the address specified in Clause 7 of this Invitation for Bids, on or before **1100 hrs.
