1. The Ministry of Finance (MoF) on behalf of the Ministry of National Planning and Infrastructure (MNPI), now invites sealed Bids from eligible and qualified bidders for the following work.

2. **International Competitive Bidding (ICB)** will be conducted in accordance with the Public Finance Regulation of Maldives, **Single Stage Two envelope** bidding procedure. Qualifications requirements are stated in the Bidding Document.

The Employer shall not be liable for any information not received by the Bidder. It is the Bidder's responsibility to verify the website for the latest information related to this Bid.
5. The Bidder shall furnish a Bid Security for each of the project for the amount specified in clause 1 of this Invitation. The Bid Security shall be valid for 28 days beyond the validity of the Bid.
6. Commencing on 30th March 2019, only a listed member of the National Contractors Registry will be eligible to participate in this tender. Only Contractors who has been qualified for the above mentioned grades in clause 1 of this invitation will be eligible to participate for this tender.
