The Bidding document, in the English language maybe purchased by interested Bidders on the submission of a written application to the Permanent Secretary and upon payment of a non-refundable fee of Mrf 2,500.00 (Maldivian Rufiyaa Two Thousand Five Hundred) in cash or by demand Draft in favor of TES, MOFT, Maldives during normal office hours on all working days from **2nd September 2012 to 11th October 2012**. The bidders who desire bid document through courier are required to pay US\$10.00 or its equivalent in MRF extra in Maldives and US\$ 40.00 extra for outside Maldives as courier charges. The employer and or his representative will not be responsible for postal delay if any for any reasons thereof.

5. Bids must be delivered to the address above on before **15th October 2012, Monday at 1200 hours**. All bids must be accompanied by a Bid security of US\$15,000.00(US dollar fifteen thousand) or its equivalent in Maldivian Rufiyaa. Late bids shall be rejected. Technical Proposals of Bids will be opened at **1400 hours** on **15th October 2012, Monday** in the presence of the Bidders' representatives who choose to attend. Price proposals of technically compliant bids will be opened subsequently at a date and time to be intimated subsequently by Ministry of Finance and Treasury.
