

# **Weekly Fiscal Developments**



The cumulative revenue and grants for the period, 01 January to 22 December is MVR 26,235.7 million. Receipts were received from tax revenues; Import Duty, GST, TGST and BPT. Most significant reciepts this week were received from BPT, GST and TSGT.

The cumulative expenditure for the period is MVR 36,321.2 million. The majority of expenditure during this period was spent on recurrent expenditure; Administrative and Operational Expenses.

The overall balance for the period is a deficit of MVR 10,085.4 million
