 - Copy of the Payment/Transaction Receipt.

The Employer shall not be liable for any information not received by the Bidder. It is the Bidder's responsibility to verify the website for the latest information related to this Bid.

6. The Bidder shall furnish a Bid Security for each of the project for the amount specified in Clause 1 of this Invitation. The Bid Security shall be valid for 148 days beyond the validity of the Bid.

Bids shall be valid for a period of **120** days from the date of bid opening and shall be delivered to the Ministry of Finance at the address specified in Clause 10 of this Invitation for Bids, on or before **1100hrs** Maldivian Time on **24th March 2019**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
