- 2. International Competitive Bidding (ICB) will be conducted in accordance with the Public Finance Regulation (Regulation No. R-158/2023) of Maldives. Qualifications requirements are stated in the Bidding Document.

  - "Foreign Direct Investment Policy" by Ministry of Economic Development and Trade.
  - "Construction Industry Contractor's Regulation" by Ministry of Construction, Housing and Infrastructure.

cost. The Employer shall not be liable for any information not received by the Bidder. It is Bidder's responsibility to verify the website for the latest information related to this Bid.

- 6. The Bidder shall furnish a Bid Security for the project for the amount specified in clause 1 of this Invitation. The Bid Security shall be valid for 28 days beyond the validity of the Bid.
- 7. Any clarifications to the project may be sent to the address in clause 10 of this invitation for bids on or before 13:00 Hours Maldivian Time on Tuesday, 29<sup>th</sup> May 2025.
- 8. Bids for this project should be submitted on or before 09:00:00hrs Maldivian Time on 4<sup>th</sup> June 2025 through Beelan Portal. Bids received for this project will be opened on 10:00:00hrs Maldivian Time on 4<sup>th</sup> June 2025.
