#	Document Name	Document Reference	Query	Response
1			In the page 64 of the bidding document (Technical Proposal, Section 4 – Bidding Forms), it is written that we need to submit an Environmental Health and Safety Plan, an Environmental Code of Conduct, a Quality Plan, a Contractors Environmental Management Plan and a Health and Safety Plan. However, in the following Plan Outlines (page 69), there is no requirement for the Quality Plan, CEMP and HSP. So, we want to know whether we only need to submit the EHS Plan and the Environmental Code of Conduct?	Bidders need to submit Covid-19 Health and Safety Plan, and Environmental Health and Safety Management Plan, and Environmental Code of Conduct in their technical proposal, as outlined on page 69. The CEMP and quality plan could be submitted by the winning bidder once the contract is awarded
2			In the page 97 (Table of Contents, Section 6 – Employer's Requirements), there is a part 9 – Environmental, Health and Safety Management Requirements, but this part is missing in the section 6. Could you provide it?	As mentioned above, the EHSP and COVID-19 H&S Plan, which are usually generic documents of contractors, are mandatory during bidding. The CEMP, the more detailed plan, can be prepared and submitted by the winning bidder after award of contract.
3			<p>We understand that this is the 3rd retender. We wish to bring to your attention (from an industry perspective) that the bid would be more competitive if the prequalification requirements are revised as follows.</p> <p>Minimum average annual turnover of USD5,000,000 calculated as total certified payments received for contracts in progress or completed, within the last five (5) years;</p> <p>Participation as a contractor, Joint Venture partner, or subcontractor in at least two contracts that have been successfully or substantially completed within the last seven (7) years (2015-2021) and that are similar to the proposed contract, where the value of the Bidder's participation for each contract exceeds USD 1,000,000. The similarity of the Bidder's participation shall be based on the physical size, nature of works, complexity, methods, technology or other characteristics as described in Section 6 (Employer's Requirements).</p>	These cannot be changed.
