 - Name and Address of the Bidder
 - Name, e-mail ID and telephone numbers of the Contact Person(s)
 - Copy of the Payment/Transaction Receipt.
4. A complete set of bidding documents and related documentation is available from **20th February 2020** on Ministry of Finance website www.finance.gov.mv for downloading free of cost. The Employer shall not be liable for any information not received by the Bidder. It is the Bidder's responsibility to verify the website for the latest information related to this Bid.
5. The Bidder shall furnish a Bid Security for each of the project for the amount specified in clause 1 of this Invitation. The Bid Security shall be valid for 28 days beyond the validity of the Bid.
