INVITATION FOR BIDS

1. The Ministry of Finance, on behalf of Ministry of Housing and Urban Development (the Employer), wish to annul the initial bidding process advertised under reference number (IUL)13-K/13/2019/86, and re-invites bids from eligible and qualified bidders for the **Design and Build of 100 Housing Units at Lh.Naifaru**.
2. The bidder shall be a listed member of the National Contractors Registry and shall satisfy the grade **GC01-01 and GC01-02** in order to be eligible to participate in this tender.
3. Interested bidders shall register with the Ministry of Finance, between **17th November 2019 to 4th December 2019**, by: (a) payment of a non-refundable Registration fee of **MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred) or USD 100.00**, by cash/cheque at the Ministry of Finance between **0830hrs and 1200hrs** on all working days, or by electronic transfer to a designated bank account, information of which can be requested through email to ahmed.jinah@finance.gov.mv; and, (b) submitting in person or e-mailing the following information:

 - Copy of the Payment/Transaction Receipt.

The Employer shall not be liable for any information not received by the Bidder. It is the Bidder's responsibility to verify the website for the latest information related to this Bid.
5. Any clarifications to the project may be sent to the address in clause 7 of this invitation for bids on or before **1400 Hours Maldivian Time on Monday, 25th November 2019.**
6. The Bidder shall furnish a bid security of **USD 100,000.00 (Hundred Thousand USD- or equivalent in MVR)** for the project. The Bid security shall be valid for 148 days from the date of bid opening.
7. Bids shall be valid for a period of 120 days from the date of bid opening and shall be delivered to the Ministry of Finance at the address specified in clause 7 of this Invitation for Bids, on or before **1100 hrs. Maldivian Time on 5th December 2019.** at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
