## **INVITATION FOR BIDS**

1. The Ministry of Finance and Treasury, on behalf of Ministry of Housing and Infrastructure (the Employer), invites bids from eligible and qualified bidders for the following works under Contractor Finance.

- 2. Local contractors must be a listed member of the National Contractors Registry and must satisfy the stated grade for eligibility. International contractors are eligible for bidding subject to registration with Ministry of Housing and Infrastructure if the bid is awarded.
- 3. The Bidder shall be registered to submit a bid upon payment of a non-refundable Registration fee of MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred) for tender from 11th May 2015 to 22<sup>nd</sup> June 2015 between 0830hrs and 1430hrs, (1000hrs and 1330hrs on the Month of Ramadan) on all working days. A complete set of bidding documents in electronic format shall be available for download from the Ministry of Finance and Treasury website <a href="www.finance.gov.mv">www.finance.gov.mv</a>
- 4. The Bidder shall submit a Tax Clearance Report obtained from Maldives Inland Revenue Authority. This document shall be dated no earlier than 5 (Five) days prior to the bid submission date.
- 5. The Bidder shall furnish a bid security of the amount specified in clause 1 of this Invitation for Bids which shall be valid for 28 days beyond the validity of the Bid. The amount of performance security shall be 5% of contract price. An advance payment of 15% of contract price will be provided upon submission of an advance payment guarantee.
- 6. A pre-bid meeting will be held on 25<sup>th</sup> May 2015 at 1300 hrs Maldivian time at the Tender Evaluation Section Meeting Room of the Ministry of Finance and Treasury.
- 7. Bids shall be valid for a period of 120 days from the date of bid opening and shall be delivered to the Ministry of Finance and Treasury at the address specified in Clause 8 of this Invitation for Bids, on or before 1300 hrs Maldivian Time on 29<sup>th</sup> June 2015, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
