





Disbursed Outstanding Debt of Public and Publicly Guaranteed Debt in MVR Millions




Disbursed Outstanding Debt as a % of Total Debt



Disbursed Outstanding Debt as a % of GDP




Disbursed Outstanding Debt by Residency as a % of GDP




Currency Composition of External Debt
(SDR Decomposed)




DOD by Creditor Category



By Instrument Type




By Remaining Maturity


DISBURSED OUTSTANDING DEBT OF BUDGETARY CENTRAL GOVERNMENT DOMESTIC DEBT


Securities By Tenure
in billions of MVR




By Participant Category

By Currency Composition



Subsidiary Loan Outstanding by Beneficiary


