Consultancy for Configuration and implementation of SAP Business Objects

1. What is the BW 7.4 DB & SP level?

Comments by MoFT Oracle DB 11.2.0.4.0 SP-level 0007

2. What is the BOBJ Version?

Comments by MoFT

We will implement latest stable version.

3. Do you have license for all add on tools inside BOBJ i.e, lumira, design studio & Crystal Reports?

Comments by MoFT

We will get the licenses, before we start implementation project.

4. Datasources described are all incorporated inside SAP BW? If so the Bex Queries are ready to use directly for the reporting?

Comments by MoFT

Transactional datasources for FI_GL and FM are activated and used in BW right now. Data modelling for other necessary datasources has to be done.

5. Does the Extraction is running inside BW from ECC for all Modules i.e., FM,FI,PS,HR & MM? Else From where we need to data is data for FM,FI,PS,HR & MM?

Comments by MoFT

At present extraction is running for FI_GL line items and FM budget/commitment line items. Data modelling for other data sources has to be done in BW.

6. Integration with External source systems (Debt management systems - CSDRMS) Using SAP PO has now changed to "extract data from SAP ECC & BPC" -

Is the third-party integration with Non-SAP system is completely out of scope? (Please refer Point 8 from the TOR document Sec. III Scope of Work).

Comments by MoFT:

Integration with Debt Management System (CS-DRMS) is out of scope now. However, there would be scenarios where we might need data to be uploaded from flat files/hierarchies to BW (refer Point 4, 5, and 8 from the TOR document Sec. III Scope of Work). Moreover, there should be seamless integration of SAP BOBJ components with SAP ECC/BW and BPC.

- 7. Consultancy Firm should bear all the expenses (including travel and accommodation) related to consultants, during the support period as well.
- -We are afraid that we may not be able to agree without knowing the number of visits and duration of visit during the post go live support for SAP BIBO. Could you please guide us for onsite requirements?
- 3. Support months increased to 7
- Agreed We will support the commercials accordingly.

Comments by MoFT:

Support period will be total 6 months, not 7 months (as described in Section IV, sub section 3)

- 4. Phase 1 & Phase 2 Installation, configurations and testing of SAP Business Objects components has been changed to 5 weeks each.
- Agreed. We will provision for the team accordingly.

Comments by MoFT:

Yes, 5 weeks for Installation, configurations and testing of SAP Business Objects components for each phase and in total 7 weeks for each phase.

5. What is the version of BPC that is planned for implementation?

BPC 10.1

6. When is the planned go-live for SAP BPC Module that is being implemented for GOM budget preparation and execution?

Comments by MoFT:

BPC is live now

7. Which Non-SAP systems are we looking for interfacing with SAP BOBJ - Refer Point number 5 in Sec. III SOW.

Comments by MoFT:

Basically we want a solution to incorporate Transactional data/Master data which is not recorded in SAP, into some of the BOBJ reports (for example revenue forecasts, Bank account Balances. etc.). These data is usually maintained manually in excel file.

8. Are these NON-SAP & SAP systems to be interfaced with SAP BOBJ directly or are you planning to use a specific ETL technology provided by SAP? - Refer Point 8 in Sec. 3 SOW

Comments by MoFT:

Integration of Non-SAP source system is out of scope now. However, there might be scenarios where we have to use flat-files for data upload

9. To facilitate automatic retrieval of data from non-SAP sources for SAP BOBJ reports, what is the size of data we are looking at from each of these non-sap Data-sources? - Refer Point 8 in Sec. 3 Scope of Work?

All the reports has to be designed and configured for BOBJ components in Phase 1 and Phase 2

Comments by MoFT:

We already use Dhivehi reports in SAP BW.

Comments by MoFT:

To be able to display charts/graphs with Dhivehi descriptions and allow reports to be viewed in Dhivehi.

Comments by MoFT:

We do not need financials now, later we will request for proposal so that you can come up with detailed proposal and financials

- 16. Sec. IV Delivery and Payments schedule mentions about the first payment (20%) is due after 1 week from the project start (Business Blueprint & Project Preparation).
- We request to differ here. As a practice, we would need 10% from this milestone to be moved to Resource Mobilisation phase

Comments by MoFT:

Usual procedure is if there is an advance payment, you would have to provide "Advance Payment Guarantee", according to our Public Finance Act.

And at this stage we would not be able to amend payment schedule, as Tender process is in progress.
