INVITATION FOR BIDS

Procurement of Outer Island Waste Collection and Integrated Solid Waste Management collection (ISWMC) Equipment – 2 Lots

- 1. The Republic of Maldives has received financing from the Asian Development Bank (ADB) toward the cost of **Greater Male' Environmental Improvement and Waste Management Project** and part of this financing will be used for payment under the Contract Package named above.
- The Ministry of Finance, on behalf of Ministry of Environment, Climate Change and Technology ("the Employer"), invites sealed bids from eligible bidders for the Procurement of Outer Island Waste Collection and Integrated Solid Waste Management collection (ISWMC) Equipment – 2 Lots with the following details.

Lot 1: Dump trucks with lifting tailgate, Roll-on/Roll off containers, mobile bin tippers. Lot 2: Waste collection bins, baler for plastic and aluminum cans.

- International Competitive Bidding (ICB) will be conducted in accordance with ADB's <u>Single Stage:</u> <u>One-Envelope</u> bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following key qualifications should participate in this bidding:

Minimum average annual turnover:

- Lot 1: USD 1,450,000
- Lot 2: USD 950,000

calculated as total payments received by the Bidder for contracts completed or under execution over the last 3 years (2018, 2019, 2020 or if available 2019, 2020, 2021)

Contractual Experience:

Successful completion as main supplier within the last 4 years (2018, 2019, 2020, 2021) of at least 2 contracts (per lot) each valued at

- Lot 1: USD 772,800
- Lot 2: USD 507,200

with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).

 - b) Once the payment has been confirmed, the Bidder shall be registered upon submitting in person or by electronic mail, the following information:
