INVITATION FOR BIDS

The Government of the Republic of Maldives has received grant funds from multi-donor Climate Change Trust Fund, administered by the World Bank, towards the cost of **Climate Change Adaptation Project (CCAP)** and intends to apply part of the proceeds of this grant to payments under the contract for **Construction of Visitors Center at Hithadhoo Ecotourism Facility**.
2. The Ministry of Finance and Treasury, on behalf of Ministry of Environment and Energy (the Employer), invite bids from eligible and qualified bidders to the **Construction of Visitors Center at Hithadhoo Ecotourism Facility**.
3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits and Grants by World Bank Borrowers dated January 2011, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.
4. Qualifications requirements are stated in the Bidding Document.
5. A complete set of the Bidding Documents in electronic format may be obtained from Tender Evaluation Section of Ministry of Finance and Treasury, from **11th May 2015 to 14th June 2015** between **0830hrs and 1430hrs** on all working days, upon payment of a non-refundable Registration fee of **MVR 500.00 (Maldivian Rufiyaa Five Hundred)**.
6. The Bidder shall submit documentary evidence (No Due Report) of no due payment to the Government of Maldives, obtained from Maldives Inland Revenue Authority. This document shall be dated no earlier than 5 (Five) days prior to the bid submission date.

8. A pre-bid meeting will be held on **25th May 2015 at 1400 hours Maldivian time** at the Ministry of Finance and Treasury.
9. The Bidder shall furnish a bid security of **MVR 70,000.00 (Maldivian Rufiyaa Seventy Thousand)** which shall be valid for 119 days from the date of bid opening. The amount of performance security shall

be 5% of contract price. An advance payment of 15% of contract price will be provided upon submission of an advance payment guarantee.

10. Bids shall be valid for a period of 91 days from the date of bid opening and shall be delivered to the Ministry of Finance and Treasury at the address specified above in Clause 7 of this Invitation for Bids, on or before **1400 hours Maldivian time on 15th June 2015**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
