

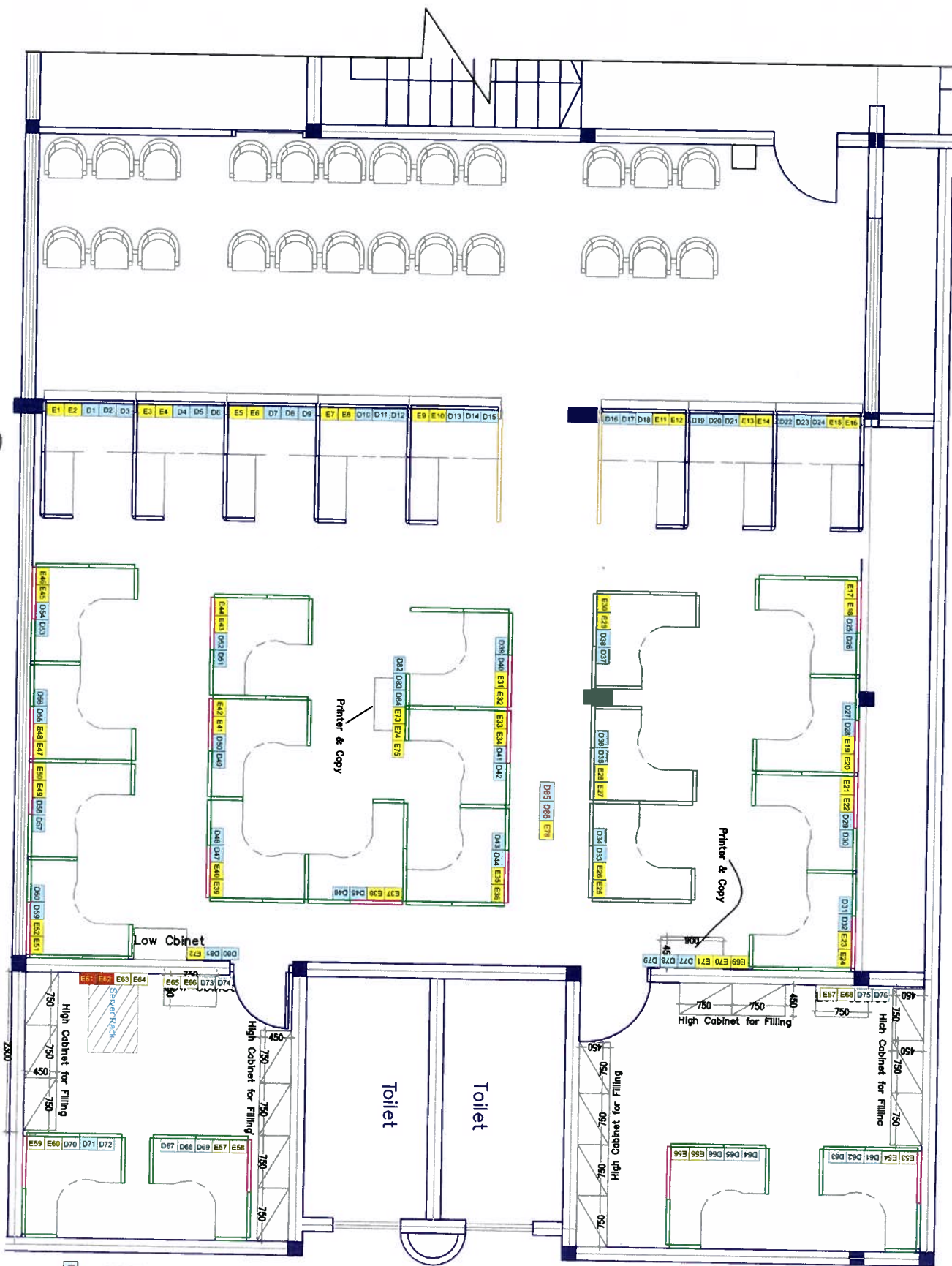

Addu Treasury sub-office network specification

Equipment Specification

* The network should be in Cat 6 standard.

1. Server rack – Standard full height rack (Brand: HP,APC,DELL or any brand which has the same quality as these brands):
 - a. Dimensions (42U 600mm wide x 1070mm deep)
 - b. Should include the roof fans.
 - c. Should provide 4 vertical cable management brackets if not inbuilt in the rack.
 - d. Grounding Straps to prevent electric shock.
 - e. Basic PDU (power distribution unit)
2. Network cables – Cat 6 standard.
3. 4 Nos. 24 port Patch Panels (to be fixed to the Server rack) :
 - a. Should be 1U in size
 - b. RJ45 and in Cat 6 standard.
 - c. Should have front and back cable management units for each.
4. Keystone jacks and face plates (45 Degree) –
 - a. RJ45 and in Cat 6 standard.
 - b. For each network point.
5. 200 nos. patch codes – Standard Length (2m) and Cat 6 standard

Work Specification

- ❖ Patch panels should be fixed to the racks and network cables connected from one end to the patch panels and other end terminated to the keystone jacks for all network points shown in the diagram provided.
- ❖ The patch panels, patch codes and face plates should be labeled.
- ❖ Network connection and speed testing should be done using appropriate industry standard (e.g. Fluke) network testing device in Cat 6 standard for all data points: from patch panels to the end points. The project will be regarded as complete after a hard and a soft copy of a passed test report is provided. The network test report should include:
 - Physical node layout.
 - Detailed and summary reports of all nodes and links.
