INVITATION FOR PRE-QUALIFICATION

1. The Ministry of Finance (MoF) on behalf of the Ministry of National Planning and Infrastructure (MNPI), intends to **extend the registration period and the bid submission deadline** of the invitation number (IUL)13-K/13/2020/120 (9th April 2020) as below to pre-qualify eligible and qualified bidders for the **Extension of Runway at N. Maafaru Airport, Maldives, on E.P.C Turnkey Basis.**
2. Commencing on 30th March 2019, only a listed member of the National Contractors Registry will be eligible to participate in this tender.

Late applications will be rejected.
