1. With regard to the titled project we would like to request for the evaluation criteria set for the EoI.

Ans: Evaluation criteria:

- a) Company Profile
- b) Experience
- c) Organization & Staffing

2. We would also like to know if a sub-consultant can be in more than one proposal for these EoIs.

Ans: Sub-consultant cannot be in more than one proposal

3. When reading the Terms of Reference from the site <http://www.finance.gov.mv> for the different projects/packages it mentions that *“The following staff members will be required for each package and should not be repeated in any other packages that are applied”*, which is understood as we need to supply CV’s to be reviewed for each package. Is this applicable only for the Proposal stage and hence at this stage (EOI stage), we can apply as a general expression of interest for all packages in one submission, or do we need to define specifically during this EOI stage now?



Ans:

- The consultant have to submit separate expression of interest for each package.
- The Consultant have to submit EOI for whole package. Submission of the EOI for specific islands within a package is not allowed.
- The Consultant have to identify staff members for each package they are applying.
