



MONTHLY FISCAL DEVELOPMENTS

August 2024

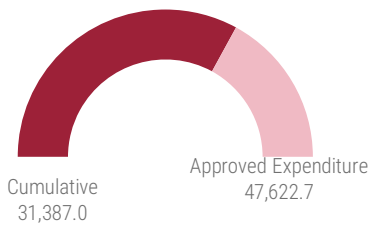
Revenue and Grants for August 2024 is 2,615.3 million, which is an increase of 5.6 percent compared to August 2023.

Total Expenditure for August 2024 decreased by 24.1 percent compared to the same period of 2023. Compared to August 2023, Capital Expenditure was 52.0 percent lower while Recurrent Expenditure decreased by 2.7 percent.

Fiscal Balance for the month of August 2024 is an overall deficit of MVR 822.4 million.

IN MILLIONS MVR

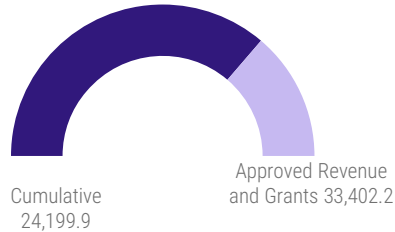


EXPENDITURE COMPOSITION - AUGUST
