INVITATION FOR BIDS

Procurement of Greater Male' Solid Waste Collection Equipment

- 1. The Republic of Maldives has received financing from the Asian Development Bank (ADB) toward the cost of **Greater Male' Environmental Improvement and Waste Management Project** and part of this financing will be used for payment under the Contract Package named above.
- 2. The Ministry of Finance, on behalf of Ministry of Environment, Climate Change and Technology ("the Employer") invites sealed bids from eligible Bidders for the:

Procurement of Greater Male' Solid Waste Collection Equipment

LOT 1: Refuse collection vehicles with lifter, skip trucks (including skip containers), multipurpose dump truck. LOT 2: Waste collection bins.

- 3. International Competitive Bidding (ICB) will be conducted in accordance with ADB's <u>Single Stage:</u> <u>One-Envelope</u> bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - LOT 1: Minimum average annual turnover of **USD 6,450,000** calculated as total payments received by the Bidder for contracts completed or under execution over the **last 3 years**;
 - LOT 2: Minimum average annual turnover of **USD 460,000** calculated as total payments received by the Bidder for contracts completed or under execution over the **last 3 years**;
 - LOT 1: Successful completion as main supplier within the **last 3 years** of at least **3 contracts** each valued at **USD 2,580,000** with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply);
 - LOT 2: Successful completion as main supplier within the **last 3 years** of at least **3 contracts** each valued at **USD 185,000** with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply);

 - a) payment of a non-refundable Registration fee of MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred) or USD 100.00 (United States Dollar One Hundred), through our online payment portal - Ban'deyri Pay (<u>https://bandeyripay.finance.gov.mv/</u>), or by electronic transfer to a designated bank account, information of which can be requested through email to above given email addresses, and;
 - b) Once the payment has been confirmed, the Bidder shall be registered upon submitting in person or by electronic mail, the following information:
 - Name and Address of the Bidder
 - Name, Email address and contact number of the Contact Person(s)
 - Copy of the Payment/Transaction Receipt.

 - together with bid security as described in the Bidding Document

Late bids will be rejected.

Bids will be opened immediately after the deadline for bid submission in the presence of Bidders' representatives who choose to attend.
