INVITATION FOR BIDS

- 1. The Government of Maldives has declared government offices to be closed from 19th March 2020 as a precautionary measure to control the spread of COVID-19. Therefore, following changes has been brought to the bid registration duration and bid submission date on Invitation for Bids Ref (IUL)13-K/13/2020/151 for the project **Survey, Design & Construction of Ha.Muraidhoo Harbour.**
- 2. Commencing on 30th March 2019, only a listed member of the National Contractors Registry will be eligible to participate in this tender.
- 3. **International competitive Bidding (ICB)** will be conducted in accordance with the Public Finance Regulation of Maldives, Single Stage Single envelope bidding procedure under ICB. Qualifications requirements are stated in the Bidding Document.

- 7. The Bidder shall furnish a bid security of <u>MVR 240,000.00</u> (Two Hundred & Forty Thousand MVR or equivalent in USD) for the project. The Bid security shall be valid for 148 days from the date of bid opening.
- 8. Bids shall be valid for a period of 120 days from the date of bid opening and shall be delivered to the Ministry of Finance at the address specified in Clause 08 of this Invitation for Bids, on or before <u>1100</u> <u>hrs Maldivian Time on 14th July 2020</u>, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
