INVITATION FOR BIDS

1. The Ministry of Finance on behalf of the Ministry of Health, invites bids from eligible and qualified bidders for the **Construction of N.Velidhoo Health Center Extension 2 Storey Building, under Contractor Finance**. Following changes has been brought to the bid registration duration and bid submission date on Invitation for Bids Ref (IUL) 13-K/13/2020/257.
2. **International Competitive Bidding (ICB)** will be conducted in accordance with the Public Finance Regulation of Maldives. Qualifications requirements are stated in the Bidding Document.
3. Commencing on 30th March 2019, only a listed member of the National Contractors Registry will be eligible to participate in this tender. International bidders shall seek all applicable Foreign Investment Registration and Foreign Direct Investment Policy requirements of Maldives prior to bid submission.
4. Interested bidders shall register with the Ministry of Finance for **the project**, between **24th September 2020 to 22nd November 2020**, by: (a) payment of a non-refundable Registration fee of MVR 1,500.00 (Maldivian Rufiyaa One Thousand and Five Hundred) or USD 100.00, through our online payment portal - Ban'deyri Pay (<https://bandeyripay.finance.gov.mv/>) and, (b) e-mailing the following information to the below given e-mail addresses:

The Employer shall not be liable for any information not received by the Bidder. It is the Bidder's responsibility to verify the website for the latest information related to this Bid.
6. The Bidder shall furnish a bid security of **MVR 1,300,000.00 (One Million Three Hundred Thousand - MVR or equivalent in USD)** for the project. The Bid security shall be valid for 148 days from the date of bid opening.
7. Any clarifications to the project may be sent to the address in clause 8 of this invitation for bids on or before **1330 Hours Maldivian Time on Tuesday, 11th October 2020.**

8. Bids shall be valid for a period of 120 days from the date of bid opening and shall be delivered to the Ministry of Finance at the address specified in Clause 9 of this Invitation for Bids, on or before **1300 hrs Maldivian Time on 23th November 2020**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening.
