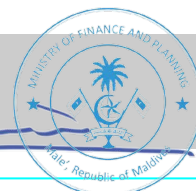

**Section VIII. Particular Conditions of Contract**

GCC reference	Particular Conditions that amend or supplement the General Conditions of Contract for the Procurement of Works
48.1	The Advance Payments shall be: 15% and shall be paid to the Contractor no later than 45 days upon signing of the contract and as per the conditions of contract.  Advance payment guarantee shall be in the form of a bank guarantee for the equivalent amount and in the form provided in the bidding documents or another form acceptable to the Employer.
49.1	The Performance Security is 10% of the Contract Price. The Performance Security shall be in the form of: a Bank Guarantee.  The Performance security shall be denominated in a freely convertible currency acceptable to the Purchaser; and shall be in the format stipulated in Section IX. The validity of the performance security shall be: <b>Until the date of issue of the Defects Liability Certificate.</b>
55.2	The amount to be withheld for failing to produce “as built” drawings and/or operating and maintenance manuals by the date required in GCC 58.1 is 10%.
58.1	The percentage to apply to the value of the work not completed, representing the Employer’s additional cost for completing the Works, is 5%.
