The Ministry of Finance and Treasury, on behalf of Ministry of Environment and Energy (the Employer), invites bids from local and international eligible and qualified bidders for the Procurement of Design and Construction works of the infrastructure, road and land point for Waste Transfer Facility at Gdh.Vaadhoo
2. International competitive Bidding (ICB) will be conducted, Single stage Dual envelope bidding procedure.

The Bidder shall be registered to submit a bid upon payment of a non-refundable Registration fee of **MVR 1,500.00 (Maldivian Rufiyaa One thousand Five Hundred)** for the project from **5th August 2018 to 17th September 2018** between **0830hrs and 1200hrs** on all working days. 4. The Bidder shall furnish a bid security of **MVR 50,000.00 (Fifty Thousand Maldivian Rufiyaa- MVR or dollars)** for the project. The Bid security shall be valid for 148 days from the date of bid opening.

Bids shall be valid for a period of 120 days from the date of bid opening and shall be delivered to the Ministry of Finance and Treasury at the address specified in Clause 9 of this Invitation for Bids, on or before **1100 hrs Maldivian Time on 18th September 2018.** at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
