8		Location of sea water intake, details and distance from Ice plant facility	Location of sea water intake point differ for different sites. All 5 sites designated for installation of 5 ice plants are adjacent to the island's main harbour as fishing vessels require easy access to the iceplant (Please refer to the drawing). Normally island harbour would be 3m deep and in these cases the inlet can be placed in the main harbour. Suitable submersible foot valve with a stainer capable to filter debris and large particles would be sufficient to installed at the end of the pump suction line. Both intake and outflow can be connected to the harbour

Type of Filters; Cartridge Filtration, Bag Filtration, or Sand filter. etc)	Water pumped from sea or lagoon would potentially consist sand and other sediment with large and small debris or particles. Contractor is required to propose an adequate sea water filter system to filter water pumped in from the sea and this water filter system would be suitable for the run of the compressor, water cooling system and overall ice making machine.
