- Development of secure systems to enable the ministry to exchange information between other government agencies and the general public.
- Study and understand complex software and mobile application systems
- Development of software and mobile application systems
- Work with end users and internal staff for timely resolution of application issues and develop new software and mobile applications/components.
- Write, revise and maintain software and mobile program documentation, operations documentation, and user guides in accordance with standards.

#### REQUIREMENT

- In-depth knowledge in HTML, CSS, PHP, JavaScript, jQuery, AJAX, SQL and other relevant open-source web development tools.
- In-depth Knowledge in development using Laravel PHP web framework (Version 8 +).
