The Government of the Republic of Maldives has received credit from the International Development Association (IDA) towards the cost of Maldives Environmental Management Project (MEMP), and it intends to apply part of the proceeds of this credit to eligible payments under the Contract for the **Construction of Berth, Landfill and Infrastructure for R. Vandhoo Regional Waste Management Facility**.
2. The Ministry of Finance and Treasury, on behalf of Ministry of Environment and Energy (the Employer), invites bids from eligible and qualified bidders to the Construction of Berth, Landfill and Infrastructure for R. Vandhoo Regional Waste Management Facility
3. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits and Grants by World Bank Borrowers dated January 2011, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.
4. Qualifications requirements are stated in the Bidding Document. Margin of preference shall not be applied. Additional details are provided in the Bidding Document.

A complete set of the Bidding Documents in electronic format may be obtained from Tender Evaluation Section of Ministry of Finance and Treasury, from **04th September 2012 to 17th October 2012 between 0830 hrs and 1400 hrs** on all working days, upon payment of a non-refundable fee of **MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred)**.

Bids shall be valid for a period of 91 days from the date of bid opening and shall be delivered to the Ministry of Finance and Treasury at the address specified above in Clause 6 of this Invitation for Bids, on or before **1100 hrs** Maldivian time on **18th October 2012**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening.
