The Bidder shall be registered to submit a bid upon payment of a non-refundable Registration fee of MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred) for this tender from 30th May 2018 to 4th June 2018 between 1030hrs and 1230hrs on all working days.
