The Government of Republic of Maldives has received a credit from the International Development Association (IDA) towards the cost of Maldives Environmental Management Project, and intends to apply part of the proceeds of this credit to payments under contract for the **Construction of a Foundation and Shed for Incinerator** to be installed at Regional Waste Management Facility at R.Vandhoo, Republic of Maldives.
2. The Ministry of Finance and Treasury, on behalf of Ministry of Environment and Energy invites bids from eligible and qualified bidders to carry out **Construction of a Foundation and Shed for Incinerator** to be installed at Regional Waste Management Facility at R.Vandhoo, Republic of Maldives.
3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits and Grants by World Bank Borrowers dated January 2011, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.
4. Qualifications requirements are stated in the Bidding Document. Margin of preference shall not be applied. Additional details are provided in the Bidding Document.

A complete set of the Bidding Documents in electronic format may be obtained from Tender Evaluation Section of Ministry of Finance and Treasury, from **19th May 2014 to 16th June 2014** between **0830 Hrs and 1430 Hrs** on all working days, upon payment of a non-refundable fee of **MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred)**.

7. The Bidder shall furnish a bid security of **MVR 50,000.00 (Maldivian Rufiyaa Fifty Thousand)** which shall be valid for 28 days beyond the validity of the Bid.
8. A pre-bid meeting will be held on **3rd June 2014** at **1100 Hrs** Maldivian time at the Ministry of Finance and Treasury.
9. Bids shall be valid for a period of 91 days from the date of bid opening and shall be delivered to the Ministry of Finance and Treasury at the address specified above in Clause 6 of this Invitation for Bids, on or before **1100 Hrs** Maldivian time on **17th June 2014**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening.
