

MONTHLY FISCAL DEVELOPMENTS

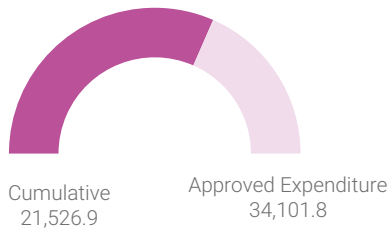
July 2022

Revenue and Grants for July 2022 stood at MVR 3,031.2 million, which is a 174.5 percent increase compared to July 2021. A significant proportion of this relative increase is due to the income tax deadline falling in July.

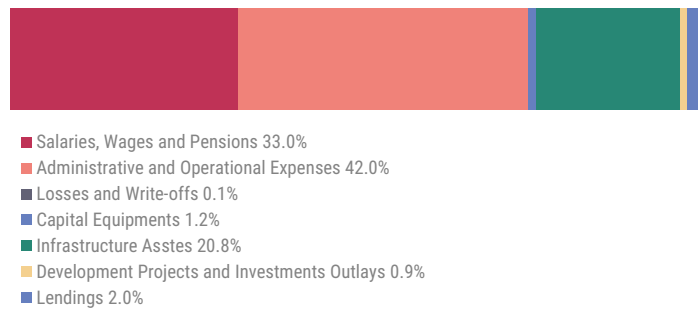
Total Expenditure for July 2022 increased by 12.6 percent compared to the same month of 2021. Compared to July 2021, Capital Expenditure decreased by 1.4 percent while Recurrent Expenditure increased by 18.2 percent. The relative hike in Recurrent Expenditure was due to rise in spending on Grants and Subsidies.

Fiscal Balance for the month of July 2022 gives an overall surplus of MVR 319.5 million.

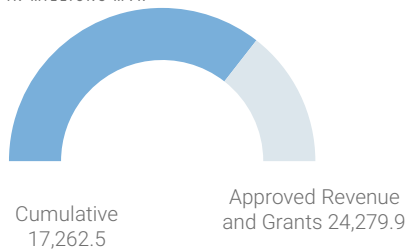
EXPENDITURE IN MILLIONS MVR



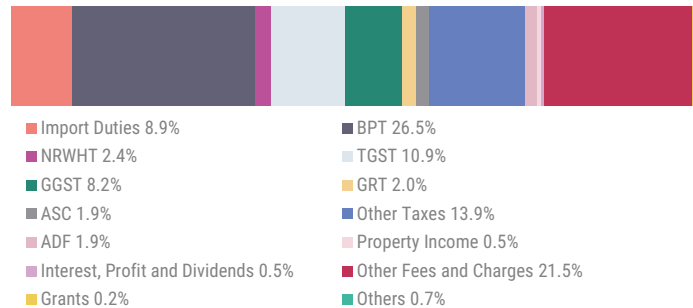
EXPENDITURE COMPOSITION - JULY
