

MONTHLY FISCAL DEVELOPMENTS

December 2021

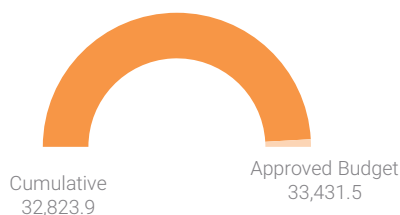
Revenue and Grants for December 2021 stood at MVR 2,756.3 million, which is a 67.51 percent increase compared to December 2020. A significant proportion of this relative increase is due to a MVR 608.7 million hike in Non-Tax Revenue.

Total Expenditure for December 2021 increased by 23 percent compared to the same month of 2020. Compared to December 2020, Capital Expenditure increased by 23 percent and Recurrent Expenditure also increased by 23 percent.

Fiscal Balance for the month of December 2021 gives an overall primary deficit of MVR 959.3 million.

EXPENDITURE COMPOSITION - DECEMBER

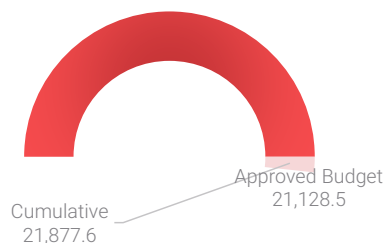

IN MILLIONS MVR



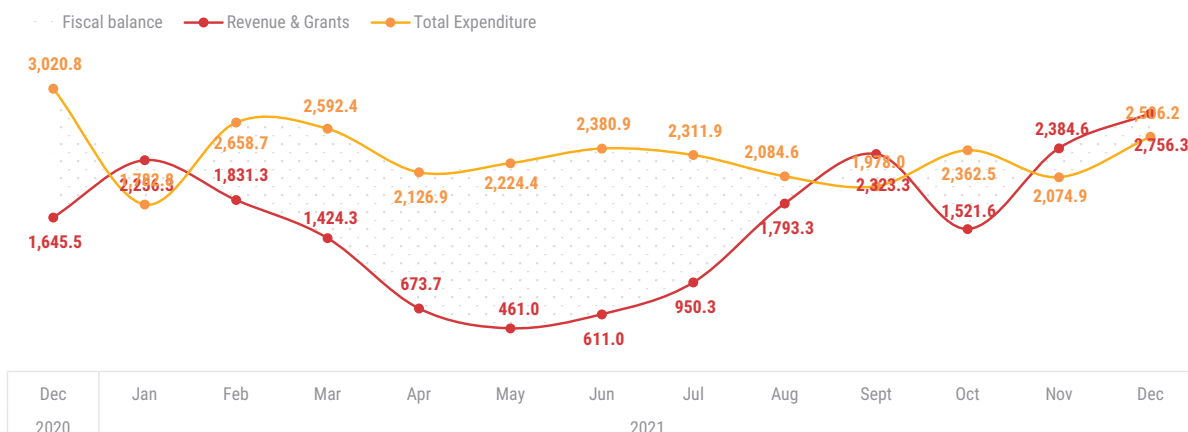
REVENUE COMPOSITION - DECEMBER
