Most significant increment in Revenue this week was from Business Profit Tax. The cumulative expenditure for the period is MVR 524.0 million. The major increment to the Expenditure this week was from Aasandha Scheme.

The overall balance for the period is a surplus of MVR 117.1 million. This is a decrease of 123.6 percent compared to the same period of the previous year.

	return the agent will receive a fee (ujr) for the service.
Sukuk Murabaha	Murabahah Sukuk is an Islamic trust contract which includes a disclosure of the
	original cost and the mark up. Murabahah in Islamic jurisprudence means a contrac
	of sale for the equivalent price of the subject matter which includes its cost along wit
	a known additional profit.
