



# MONTHLY FISCAL DEVELOPMENTS

## August 2025

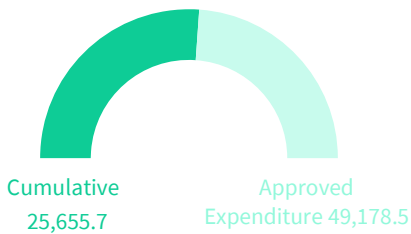
Revenue and Grants for August 2025 is 2,627.7 million, which is an increase of 4.0 percent compared to August 2024.

Total Expenditure for August 2025 decreased by 6.7 percent compared to the same period of 2024. Compared to August 2024, Capital Expenditure was 47.2 percent lower while Recurrent Expenditure increased by 5.7 percent.

Fiscal Balance for the month of is an overall deficit of MVR 442.4 million.

IN MILLIONS MVR

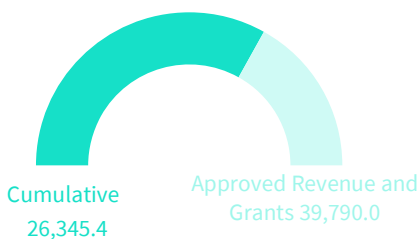


### EXPENDITURE COMPOSITION - AUGUST
