## INVITATION FOR BIDS

1. The Government of the Republic of Maldives has received financing from Opec Fund for International Development (OFID) and intends to apply portion of the financing for eligible payments under the contract for the following projects.
2. The Ministry of Finance (MoF) on behalf of the Ministry of National Planning and Infrastructure (MNPI), now invites sealed Bids from eligible and qualified bidders for the following works.

Interested bidders shall register with the Ministry of Finance, between **23<sup>rd</sup> December 2019 to 22<sup>nd</sup> January 2020 between 0830hrs and 1200hrs** on all working days, by: (a) payment of a non-refundable Registration fee of **MVR 1,500.00** (Maldivian Rufiyaa One Thousand Five Hundred) or USD 100.00, by cash/cheque at the Ministry of Finance between 0830hrs and 1200hrs on all working days, or by electronic transfer to a designated bank account, information of which can be requested through email to [hawwa.maldha@finance.gov.mv](mailto:hawwa.maldha@finance.gov.mv); and, (b) submitting in person or e-mailing the following information:

6. The Bidder shall furnish a Bid Security for each of the project for the amount specified in clause 1 of this Invitation. The Bid Security shall be valid for 28 days beyond the validity of the Bid.
7. Commencing on 30<sup>th</sup> March 2019, only a listed member of the National Contractors Registry will be eligible to participate in this tender. Only Contractors who has been qualified for the above mentioned grades will be eligible to participate for this tender.

Late bids will be rejected.
