3. The Bidder shall furnish a bid security of the amount specified in clause 1 of this Invitation or equivalent in USD for each lot, which shall be valid for 148 days from the date of bid opening. The amount of performance security shall be 5% of contract price. An advance payment of 15% of contract price will be provided upon submission of an advance payment guarantee.
4. A **pre-bid meeting** will be held on **5<sup>th</sup> March 2018** at **1300** hrs. Maldivian time at the National Tender Meeting Room of the Ministry of Finance and Treasury. Any **Clarifications** to the project may be sent to the address in clause 6 of this invitation for bids on or before **1200** Hours Maldivian Time on Thursday, **8<sup>th</sup> March 2018**.
5. Bids shall be valid for a period of 120 days from the date of bid opening and shall be delivered to the Ministry of Finance and Treasury at the address specified in Clause 6 of this Invitation for Bids, on or

before **1200 hrs.** Maldivian Time on **14<sup>th</sup> March 2018**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
