## INVITATION FOR BIDS

### ESTABLISHMENT OF QUARANTINE FACILITY IN HULHUMALE'

Financing No.: MAL-040

1. The Government of Maldives has received financing from the Islamic Development Bank (IsDB) toward the cost of the **Establishment of Quarantine Facility in Hulhumale' Project**, and it intends to apply part of the proceeds toward payments under the contract for **Construction of Quarantine Facility at Hulhumale'**.
2. The Ministry of Finance and Treasury now invites sealed bids from eligible bidders for the **Construction of Quarantine Facility at Hulhumale'**.
3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures as specified in the IsDB's Guidelines for Procurement of Goods and Works under Islamic Development Bank Financing (current edition), and is open to all eligible bidders as defined in the guidelines. Qualifications requirements are stated in the Bidding Document.
4. The Bidder shall be registered to submit a bid upon payment of a non-refundable Registration fee of **MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred)** from **June 1, 2015 to August 2, 2015** between **0830hrs and 1430hrs** on all working days. Bids shall be valid for a period of 180 days from the date of bid opening and shall be delivered to the Ministry of Finance and Treasury at the address specified above in Clause 5 of this Invitation for Bids, on or before **1100 hours Maldivian time on August 3, 2015 (Monday)**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected and returned unopened.
