As at 06 August 2020, total spending towards COVID-19 health efforts stood at MVR 1,114.1 million; a 1.4% increase from the week before In this review period 53.9% of total health spending was committed-spending.

In terms of week-on-week spending, NDMA spent MVR 12.4 million on operational services related COVID-19 health efforts. This spending is significantly higher compared its peers as NDMA's scope also include rent payments for quarantine facilities. Other noteworthy spendings were on medical consumables and on travel pertaining to health efforts by IGMH and MoH.

As at 06 August 2020, total disbursements made to ERP schemes stood at MVR 699.0 million; an 18.6% increase from the week before. To date, total disbursements made towards the Income Support scheme, COVID-19 Recovery Loan scheme and Discount on Electricity Bills were MVR 37.0 million, MVR 650.0 million and MVR 12.0 million, respectively.

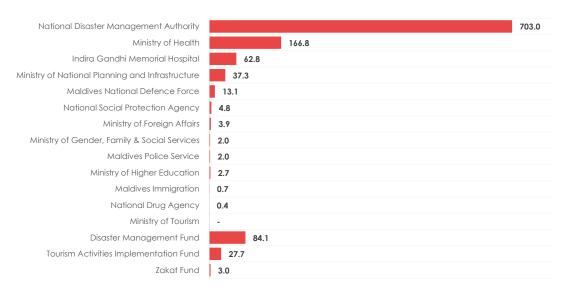
Over the past week, additional disbursements of MVR 100 million and MVR 9.8 million were made to banks implementing the COVID-19 Recovery Loan scheme and NSPA for the implementation of the Income Support scheme, respectively. No further allocations were made to any other schemes in that week.

Note that additional allocations may not yet be reflected in the Public Bank Account. Data are likely to vary as reconciliation work is anguing

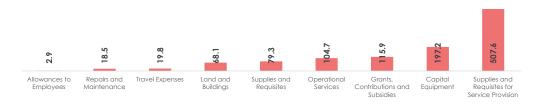
## By Business Area & Trust Fund\*\*\*

| Income Support                                   | This scheme will provide allowances to Maldivian workers who are unemployed or had their salaries (earnings for self-employed/ freelance workers) affected due to the COVID-19 pandemic.   |
| COVID-19 Recovery Loan<br>Scheme                 | The scheme is designed to provide financing for large businesses, SMEs, self-employed and freelance individuals affected by the COVID-19 pandemic. Ministry of Finance has partnered with Bank of Maldives and SME Development Finance Corporation to support the implementation of this scheme. |
