# Invitation for the Expression of Interest for Design and Build an Incineration Facility in the Island of Thilafushi, Maldives, Under Contractor Finance.

#### Introduction

Solid waste management is a particular challenge in the Maldives because of the especially high economic and social dependence on a healthy marine environment. In recent years, there has been a significant increase in the magnitude of waste management problems in Male' for a number of reasons, including but not necessarily limited to strong rural-to-urban migratory pressure from the subsistence economies of the outer atolls to the public sector dominated cash economy of Male'. The worsening waste management situation is increasingly resulting in pollution of the environment and the generation of conditions prejudicial to public health. Predicting the threats to the economic development, the Ministry of Environment and Energy (MEE) on behalf of the Government of Maldives, has decided to bring a fast and a proper solution for the waste management situation in Male' City along with other islands in the Country.

The large quantities of waste generated in Malé are taken to the disposal site on the island of Thilafushi, where the waste is burned before open dumping in a bunded lagoon. Thilafushi also receives large quantities of waste from other islands in the vicinity and mostly from tourist resorts. It is anticipated that the Thilafushi receives approximately 500 tons of waste per day from Greater Male' and resorts in four neighbouring atolls of Kaafu, Alifu Alifu, Alifu Dhaalu and Vaavu and also periodically from inhabited islands of the above atolls. Therefore, it is considered by far the largest waste disposal site in the Maldives. In such, the Government of the Republic of Maldives therefore wishes to improve the condition at the island of Thilafushi waste disposal site by developing it into a regional waste management facility.

#### Scope of Work

The Ministry of Environment and Energy is proposing to undertake, under its mandate, the development of a state-of-the-art waste management facility on the island of Thilafushi that caters to Greater Male', resorts, inhabited islands and other industrial islands in the above atolls. The Ministry wishes to put the project into two phases as follows,

- <u>First Phase</u>: Design and build of an incineration facility with a capacity of 100 tons per day. The facility shall be designed and developed as to enable to expand upto another 400 tons in a near future.
- <u>Second Phase</u>: 400 tons of modular incineration system that synchronizes with the first phase and a recycling plant.

Consequently, The Ministry of Finance and Treasury on behalf of the Ministry of Environment and Energy now invites reputable contractors (companies) to express interest to undertake the First Phase of the project under Contractor Finance.

The first phase of the project involves of the following:

- Design and build an incineration facility with a capacity of 100 tons per day including a waste reception and feeding system
- · Waste to energy system

## Prequalification requirement

Interested and competent contractors wishing to carry out the above project must submit the following documents with the Expression Of Interest under Contractor Finance.

- Evidence of registration
- · Comprehensive company profile
- Experience
- Proposed management team, organizational chart, with CVs' of key personnel to be deployed on the Project.
- Evidence of successfully executing a single project within the last 7 years, similar in scope and complexity and costing not less than US\$ 10 million (ten million United States Dollar).
- Evidence of credit line of a minimum US\$ 5 million,
- Proposed method statement for the execution of the project.
