
# MONTHLY FISCAL DEVELOPMENTS December 2019



Revenue and Grants for December 2019 increased by 15.8 percent compared to the corresponding month of 2018, contributed by a 14.3 percent increase in Non-Tax Revenues. Tax Revenues increased by 15.8 percent compared to December 2018 primarily due to increased Goods and Services Tax and Import Duties.

Total Expenditure increased by 35.9 percent increase compared to December 2018 as a result of an increase in capital expenditure. Capital expenditure was driven by a rise in spending on PSIPs and Lendings. Spending on recurrent expenditure increased by 19.8 percent mainly due to increased Administrative and Operational Expenses.

Fiscal balance for the month of December 2019 gives an overall deficit of MVR 955.9 million.

#### Note:

Total expenditure include figures where budget was consumed in 2018, but has been recorded as an expense in 2019. Negative figures represent reversal entries posted to the Public Accounting System during the review period for which purchase orders were raised in previous periods. Cumulative 2019 expenditure is likely to be understated as expenditure for this period includes reversal entries for transactions for which budget has been consumed in 2018.
