The Government of the Republic of Maldives has received grant funds from multi-donor Climate Change Trust Fund, administered by the World Bank, towards the cost of Clean Energy for Climate Mitigation (CECM) Project and intends to apply part of the proceeds of this grant to payments under the contract for the Supply and Installation of Automatic Generator Controllers for integration with Grid-tied Solar Photovoltaic System on GDh. Thinadhoo Island.
- 2. The Ministry of Finance and Treasury, on behalf of Ministry of Environment and Energy (the Employer), invites bids from eligible and qualified bidders to the Supply and Installation of Automatic Generator Controllers for integration with Grid-tied Solar Photovoltaic System on GDh. Thinadhoo Island.
- 3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits and Grants by World Bank Borrowers dated January 2011, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.
- 4. Qualifications requirements are stated in the Bidding Document. Margin of preference shall not be applied. Additional details are provided in the Bidding Document.
