## **INVITATION FOR BIDS**

- 1. The Ministry of Finance on behalf of the Ministry of Health, invites bids from eligible and qualified bidders for the Construction of N. Velidhoo Health Center Extension 2 Storey Building, under Contractor Finance.
- 2. **International Competitive Bidding (ICB)** will be conducted in accordance with the Public Finance Regulation of Maldives. Qualifications requirements are stated in the Bidding Document.

- 5. The Bidder shall furnish a bid security of MVR 1,300,000.00 (One Million Three Hundred Thousand MVR or equivalent in USD) for the project. The Bid security shall be valid for 148 days from the date of bid opening.

- 7.
