1. The Ministry of Finance (MoF) on behalf of the Ministry of National Planning and Infrastructure (MNPI), now invites sealed Bids from eligible and qualified bidders for the following work.

5. The Bidder shall furnish a Bid Security for each of the project for the amount specified in clause 1 of this Invitation. The Bid Security shall be valid for 28 days beyond the validity of the Bid.
6. Commencing on 30th March 2019, only a listed member of the National Contractors Registry will be eligible to participate in this tender. Only Contractors who has been qualified for the above mentioned grades in clause 1 of this invitation will be eligible to participate for this tender.
