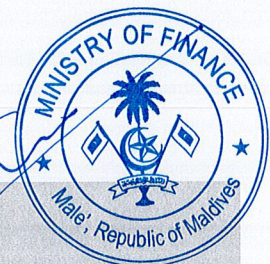

1			Under Lot No:1 (1.1) – Do they need 21 units of Dump trucks or ordinary cargo trucks?	It's ordinary open top cargo truck with lifting tail gate
2			If what they need are Dump trucks. Dump trucks comes with swing type tail gates. However, they have asked for lifting tail gates which usually comes with normal cargo trucks (not with Dump trucks). Please get clarification about what exactly they need	See previous answer. Ordinary open top cargo truck with lifting tail gate
3			Under Lot 1 there are 3 subtitles: 1.1 Dump trucks 1.2 Roll on – Roll off containers 1.3 Mobile Bin tippers Do we need to supply whole Lot 1 together OR A subtitle item (e.g., 1.1: Dump Trucks) only if we so desire?	Yes, the bidder is requested to provide all 3 sub-lots together
4			Would like to clarify if the mandatory spare parts stated in the Technical Specifications is per dumptruck or total for all dumpstrucks?	The mandatory spare parts are for the cargo/dump truck. The bidder is requested to provide an adequate set for the 21 units (that each unit is receiving the same spare parts)
5			Can we request to change the wheelie bin rubber wheel size from 250mm diameter to 200mm diameter?	Yes accepted
6		Wheelie Bins	Can we request to change the wheelie bin rubber wheel size from 250mm diameter to 200mm diameter?	Yes accepted

No, the min required pressing force is 60 KN which is approx 6 t (not 20 t) this also approx the max pressing force. Max allowed is 80 KN
14			Can the three enterprises jointly bid?	yes
15			Dump truck with lifting tailgate:Almost all the parameter is Compliant. The only different is the Sliding windows right/left. normally it is up/down, can you help us confirm the sliding windows method.	Yes, sliding window up/down acceptable
16			Roll-on/Roll-off containers 1) about thickness: it is required to be side 3mm, bottom 5mm. as the big capacity, we recommend to use at least side 4mm, bottom 5mm. so that to ensure the quality. 2) about the door: it is required Double wing door with safety lock. as the Inner dimensions requires to be 6,000 x 2,300 x 2,400 mm, which means the overall size will be around 6300x2550x2650MM. it means the height will be more than 2M. it is difficult to open it manually and also very dangerous. we recommend to use Hydraulic door. it will be much more easier and more safe to operate.	1) accepted 2) accepted
17			Mobile bin tippers Normally, there are two machines for 660L-1100L and 80-360L. because they are with different lifting ways. as per tender, it requires to combined one. it need to design and produce especially.	No there are existing machines suitable for both sizes but given the circumstances bin tippers suitable only for 80-360 l are acceptable

18			It is mentioned in the bid documents that local or international bidders should be GST registered in Maldives. As we are a solely Sri Lankan incorporated company, please advise us the procedure of registering our company for GST in Maldives.	If the supplier is registered in Maldives only they have to include GST.
19			As the tender document is inviting foreign bidders to bid on CIF basis to the Ministry of Finance - Maldives (Consignee) . Please advise us on the points below. a. Who will be paying applicable taxes, duties, Ports Authority charges at the time of clearance in Maldives? b. Who will be clearing and transporting goods to the final destination? c. What is the final destination? (Which Island)	Duty will be exempted. Clearance and transportation of the goods to final destination will be done by the Purchaser. The equipments supplied will be distributed between 21 islands.
20			Can you please advise us applicable duty and taxes for brand new Garbage Dump Truck, Roll-on/Roll Containers and Mobile Bin Lifters in Maldives?	Duty will be exempted. For local bidders and international bidders who have registered their business in Maldives, then GST will be applicable.
