

MONTHLY FISCAL DEVELOPMENTS

June 2021

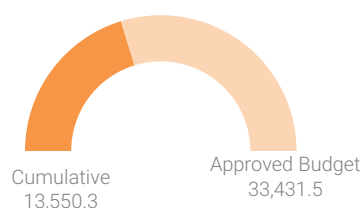
Revenue and Grants for June 2021 stood at MVR 1,433.8 million, which is a 90.2 percent increase compared to June 2020. A significant proportion of this increase is due to improved performance of GST.

Total Expenditure for June 2021 declined by 6.6 percent compared to the same month of 2020. Compared to June 2020, Capital Expenditure declined by 57.6 percent while Recurrent Expenditure increased by 23.2 percent. The hike in Recurrent Expenditure was contributed by increased Grants, Contributions and Subsidies.

Fiscal Balance for the month of June 2021 gives an overall deficit of MVR 697.4 million.

EXPENDITURE COMPOSITION - MAY

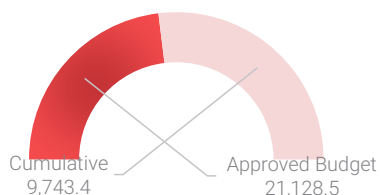

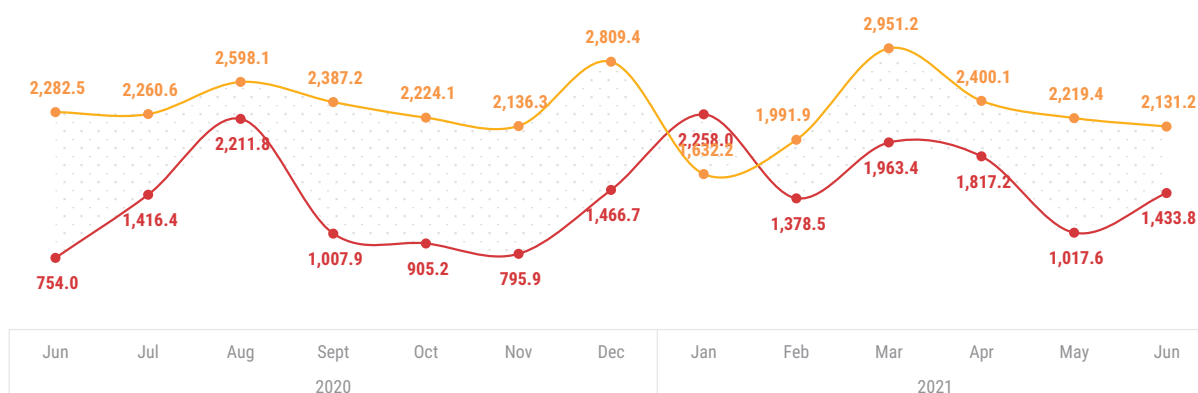
