



# MONTHLY FISCAL DEVELOPMENTS

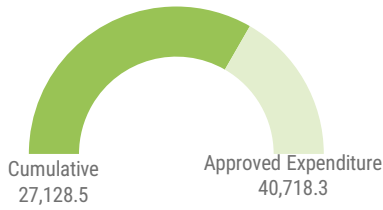
## July 2023

Revenue and Grants for July 2023 is 4,460.0 million, which is a 46.4 percent increase compared to July 2022.

Total Expenditure for July 2023 increased by 40.5 percent compared to the same month of 2022. Compared to July 2022, Capital Expenditure increased by 89.1 percent while Recurrent Expenditure increased by 23.9 percent.

Fiscal Balance for the month of July 2023 is an overall surplus of MVR 578.8 million.

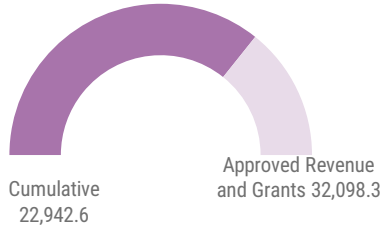
### EXPENDITURE IN MILLIONS MVR



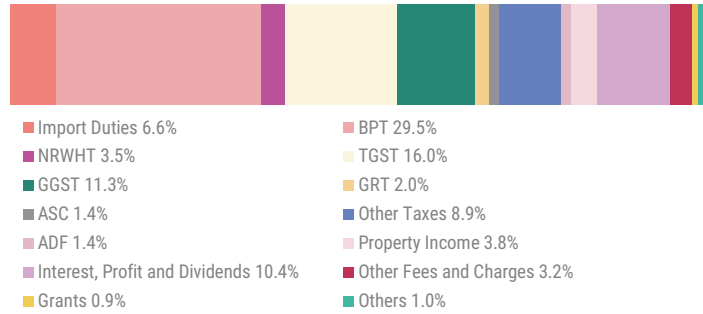
### EXPENDITURE COMPOSITION - JULY
