## INVITATION FOR PRE-QUALIFICATION

- 1. The Ministry of Finance (MoF) on behalf of the Ministry of National Planning and Infrastructure (MNPI), has received financing from Abu Dhabi Fund for Development (ADFD) and intends to pre-qualify eligible and qualified bidders for the Extension of Runway at N. Maafaru Airport, Maldives, on E.P.C Turnkey Basis.
- 2. Commencing on 30th March 2019, only a listed member of the National Contractors Registry will be eligible to participate in this tender.
- 3. Interested bidders shall register with the Ministry of Finance, between 12<sup>th</sup> April 2020 to 19<sup>th</sup> April 2020, by: (a) payment of a non-refundable Registration fee of MVR 500.00 (Maldivian Rufiyaa Five Hundred) or USD 32.00, by cash/cheque at the Ministry of Finance between 0830hrs and 1200hrs ( During Ramazan: 9:30 to 11:30) on all working days and for the period of Government closure during the State of Health Emergency: 9:30 to11:30 on Mondays and Wednesdays or by electronic transfer to a designated bank account, information of which can be requested through email to aminath.naaheen@finance.gov.mv; and, (b) submitting in person or e-mailing the following information:
