INVITATION FOR PRE-QUALIFICATION

The Ministry of Finance (MoF) on behalf of the Ministry of National Planning and Infrastructure (MNPI), has received financing from Abu Dhabi Fund for Development (ADFD) and intends to pre-qualify eligible and qualified bidders for the **Extension of Runway at N. Maafaru Airport, Maldives, on E.P.C Turnkey Basis.**
2. Commencing on 30th March 2019, only a listed member of the National Contractors Registry will be eligible to participate in this tender.
